### ORDER:

The Hon'ble Minister for Health and Family Welfare has made the following Announcement in the floor of the Tamil Nadu Legislative Assembly during the Demand No.19.

### Announcement No.12

"சேலம் மாவட்டம் - ஏற்காடு அரசு மருத்துவமனையில் உலக வங்கி திட்டத்தின் கீழ் ரூபாய் 1.05 கோடி மதிப்பீட்டில் நவீன பிரேத பரிசோதனை கட்டடம் மற்றும் கருவிகள் வழங்கப்படும்."

2. Based on the above announcement, the Project Director, Tamil Nadu Health System Reform Program has sent a proposal to establish a modern post mortem block at Yercaud Government Hospital, Salem District and furnished the vital statistics and general performance relates of that Government Hospital, Yercaud, and the estimated budget for the activity at a total cost of Rs.1.05 Crore which is to be undertaken during the year 2022-2023.

3. The Project Director, Tamil Nadu Health System Reforms Program has stated that the above proposal has been approved in the District Health Assembly / State Health Assembly / State Empowered Committee and hence requested the Government to issue necessary orders in this regard.

4. The Government after careful consideration of the proposal of the Project Director, Tamil Nadu Health System Reform Program have decided to accept the same and accordingly issue the following orders:-

- (i) Sanction is accorded for a sum of Rs.1,04,73,010/- (Rupees One Crore four lakh seventy three thousand and ten only) towards the establishment of modern post mortem block (construction including mortuary room and logistics) in Government Hospital at Yercaud taluk of Salem District through PWD (Medical wing).

- (ii) The Director of Medical and Rural Health Services is authorized to draw and utilize the amount sanctioned above.
- (iii) A separate account to be maintained exclusively for Tamil Nadu Health System Reform Program funds in Directorates, Districts and Facilities (till beneficiary level if needed) involved, which should be operated by Joint Signatory.

5. The expenditure sanctioned in para 4 (i) above shall be debited to the following head of account:-

4210 Capital Outlay on Medical and Public Health -01 Urban Health Services -200 Other Health Scheme - Externally Aided Projects - PD - Tamil Nadu Health Systems Reforms Project – Administrated by Director of Medical and Rural Health Services - 416 Major Works – 01 Major Works.

6. The expenditure sanctioned in para-4 (i) above shall constitute an item of "New Service" and the approval of Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Director of Medical and Rural Health Services is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (BG.I) Department directly in Form A appended to the Tamil Nadu Contingency Fund Rules 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG.I) Department. The Director of Medical and Rural Health Services is requested to send necessary explanatory notes to include the above expenditure in the Supplementary Estimates for the year 2022-2023 to Finance (BG-I/Health-II) Department at the appropriate time without fail.

7. The Director of Medical and Rural Health Services is a estimating, Reconciling and controlling authority of the above new head of account. The pay and Accounts Officer / Treasury Officer concerned are directed to open the above new Head of Account in their books.
