In continuous of the above, the Project Director, Tamil Nadu Health System Reform Program in the letter read above, has requested to sanction Rs.52,66,800/- towards the recurring cost of salary of Trauma Registry Assistants in the above said 11 New Medical College Hospitals for the year 5 (2023-2024) and furnished the budget estimate as follows:-

4. The above proposal was approved in the State Empowered Committee.

5. The Government after careful consideration of the proposal of the Project Director, Tamil Nadu Health System Reform Program have decided to accept the same and accordingly issue the following orders:-

- (i) Sanction is accorded for a sum of Rs.52,66,800/- ((Rupees Fifty two lakhs sixty six thousand and eight hundred only) towards the salary of trauma registry assistants including EPF in 11 New Medical College Hospitals as mentioned above.

- (ii) The Director of Medical Education and Research is authorized to draw and disburse the amount sanctioned above through the Deans concerned.
- (iii) A separate account to be maintained exclusively for Tamil Nadu Health System Reform Program funds in Directorates and facilities involved which should be operated by joint signatory.

6. The expenditure sanctioned in para 5 (i) above shall be debited to the following head of account:-
