ORDER:

In the letter sixth read above, the Project Director, Tamil Nadu Health Systems Project has stated that the State Head Operation, GVK EMRI and General Secretary, Indian Red Cross Society have requested to sanction conveyance allowance of Rs.150/- per head per day to EMTs and EROs and Pilots (Drivers) considering the inconveniences in transport facility to come for work due to complete lockdown in Tamil Nadu from 01.06.2021 to 21.06.2021.

2. The Project Director, Tamil Nadu Health Systems Project has furnished the head count details for the period from 01.06.2021 to 21.06.2021 and total expenditure as below:

- 3. The Project Director, Tamil Nadu Health Systems Project has requested the Government to allot a sum of Rs.1,87,50,900/- (Rupees One Crore, Eighty Seven Lakh, Fifty Thousand and Nine Hundred only) and to allot a sum of Rs.20,73,750/- (Rupees Twenty Lakh Seventy Three Thousand Seven Hundred and Fifty Only) for conveyance allowance for the periods from 01.06.2021 to 21.06.2021.
- 4. The Government after careful examination of the proposal of the Project Director, Tamil Nadu Health Systems Project have decided to accept the same and issue orders as follows:
 - i. Sanction is accorded for an amount of Rs.2,08,24,650/- (Rupees Two Crore, Eight Lakh, Twenty Four Thousand Six Hundred and Fifty Only) to the Project Director, Tamil Nadu Health Systems Project towards special conveyance allowance to the Pilots and Emergency Management Technicians of 108 Ambulance Service and Pilots of Free Hearse Service and JSSK for the period from 01.06.2021 to 21.06.2021.
 - ii. The Project Director, Tamil Nadu Health Systems Project is permitted to draw the above sanctioned amount.
- 5. The expenditure sanctioned in para 4(i) above, Rs.1,87,50,900/- (Rupees One Crore, Eighty Seven Lakh, Fifty Thousand and Nine Hundred only) shall be debited under the following head of account:-
 - "2210- Medical and Public Health- 80 General 800 other Expenditure State's Expenditure JF Ineligible cost of Emergency Ambulance Service under National Rural Health Mission Scheme 309 Grants in Aid 03 Grants for specific Schemes.
