#### **ORDER:**

In the letter read above, the Project Director, Tamil Nadu Health Systems Project has stated that three vehicles were provided as one each to Namakkal Medical College Hospital, Rasipuram Government Hospital and Tiruchengodu Government Hospital under Corporate Social Responsibility funds towards JSSK drop back services. The Director of Public Health and Preventive Medicine was requested to instruct Deputy Director, Namakkal to hand over the 3 vehicles procured under Corporate Social Responsibility funds to EMRI through the Project Director, Tamil Nadu Health Systems Project.

- 2. The Project Director, Tamil Nadu Health Systems Project has stated that the Mission Director, National Health Mission requested her to take over the above said 3 vehicles for JSSK Drop Back Services and to be added in the existing 102 Drop Back Service transportation operated by service provider GVK-EMRI under Tamil Nadu Health Systems Project.
- 3. The Project Director, Tamil Nadu Health Systems Project has requested the Government to consider the request of the Mission Director, National Health Mission and accept the same to include three JSSK Drop Back Vehicles donated under Corporate Social Responsibility activities in the existing fleet strength of 102 services operated by GVK-EMRI service provider under Tamil Nadu Health Systems Project. Tamil Nadu Health Systems Project may be empowered to rationalize the vehicles based on need.

- 4. The Government after careful consideration of the request of the Project Director, Tamil Nadu Health Systems Project have decided to accept the same and accordingly the Project Director, Tamil Nadu Health Systems Project is permitted.
  - To accept the three JSSK Drop Back Vehicles donated under Corporate Social Responsibility activities in the existing fleet strength of 102 services operated by GVK-EMRI service provider under Tamil Nadu Health Systems Project.
  - To bear the operational costs for further usage under 102 services.
  - iii. To render assistance to complete the formalities for ambulances inducted in regular operation.
