ORDER:

The Hon'ble Chief Minister has made the following announcement:-

"Sanction a sum of Rs.5000/- (Rupees Five Thousand Only) as special allowance to 108 Ambulance Services, Free Hearse Services and JSSK (Drop Back Services) employees in appreciation of their selfless service during COVID-19 Pandemic."

- 2. Based on the above announcement, the Project Director, Tamil Nadu Health Systems Project has forwarded a proposal and requested the Government to sanction a sum of Rs. 2,85,35,000/-(Rupees Two Crores Eighty Five Lac and Thirty Five Thousand Only) towards special allowance at a rate of Rs.5000/-(Rupees Five Thousand Only) to 5707 staffs working in GVK-EMRI and Indian Red Cross Society.
- 3. The Government after careful examination of the proposal of the Project Director, Tamil Nadu Health Systems Project have decided to accept the same and issue following orders:
 - i. Sanction is accorded for a sum of Rs.2,85,35,000/-(Rupees Two Crores Eighty Five Lakhs and Thirty Five Thousand Only) towards special allowance at a rate of Rs.5000/-(Rupees Five Thousand Only) to 5707 staffs working in GVK-EMRI and Indian Red Cross Society in appreciation of their selfless service during COVID-19 Pandemic as detailed below.

- 5. Necessary funds of Rs.2,85,35,000/- will be provided in RE / FMA 2020-2021. Pending provision of such funds in RE/FMA 2020-2021, the Project Director, Tamil Nadu Health Systems Project is authorized to draw and disburse the amount sanctioned in para 3(i) above. However, this expenditure shall be brought to the notice of the legislature by Specific inclusion in the Supplementary Estimates 2020-2021. The Project Director, Tamil Nadu Health Systems Project is also directed to include this expenditure while sending the budget proposals for RE/FMA 2020-2021 and draft explanatory notes for Supplementary Estimates 2020-2021 to Government in Finance (Health-II) (BG-I) Department without fail.
