#### ORDER:

The Hon'ble Minister for Health and Family Welfare has made the following Announcement in the floor of the Tamil Nadu Legislative Assembly during the Demand No.19.

#### Announcement No.29:-

"இராமநாதபுரம் மாவட்டம் பரமக்குடி அரசு மருத்துவமனைக்கு உலக வங்கி திட்டத்தின் கீழ் ரூபாய் 20 இலட்சம் மதிப்பீட்டில் C-arm உடன் எலும்பு முறிவு அறுவை சிகிச்சை மேசை(Fracture Table) வழங்கப்படும்".

- 2. Based on the above announcement, the Project Director, Tamil Nadu Health System Reform Program has sent a letter read above along with the justification, vital statistics and general performance relates to the Paramakudi Government District Head Quarters Hospital, Ramanathapuram District and requested to provide a High End Image Intensifier C-Arm & C-Arm compatible Orthopaedic Fracture Table with attachments to that hospital.
- 3. The Project Director, Tamil Nadu Health System Reform Program has worked out the cost involved in the above activity and furnished as follows:-

- 4. The Project Director, Tamil Nadu Health System Reform Program has stated that the State Empowered Committee had approved the proposal for provision of a High End Image Intensifier C-Arm & C-Arm compatible Orthopaedic Fracture Table with attachments to the Paramakudi District Head Quarters Hospital, Ramanathapuram District and requested the Government to issue necessary orders in this regard.
- 5. The Government after careful consideration of the proposal of the Project Director, Tamil Nadu Health System Reform Program have decided to accept the same and accordingly issue the following orders:-
  - (i) Sanction is accorded for a sum of non-recurring expenditure of Rs.20,00,000/- (Rupees Twenty lakhs Only) for provision of High End Image intensifier C-Arm & C-Arm compatible Orthopaedic Fracture Table with attachments to Paramakudi District Head Quarters Hospital, Ramanathapuram District.
  - (ii) The Director of Medical and Rural Health Services is authorized to draw and deposit the above sanctioned amount into Personal Deposit account of Tamil Nadu Medical Services Corporation Limited.
  - (iii) A separate account to be maintained exclusively for TNHSRP funds in Directorates and facilities involved which should be operated by joint signatory.
- 6. The expenditure sanctioned in para 5 (i) above shall be debited to the following head of account:-
