ORDER:

In Government Order first read above, orders were issued to construct a building for Multi Super Speciality Hospital in the premises of King Institute of Preventive Medicine and Research, Guindy, Chennai at a cost of Rs.230.00 Crore. In Government Order second read above, it is upgraded into 1000 beds.

2. The Project Director, Tamil Nadu Health System Reform Program in her letter third read above, has furnished the budget estimation of Rs.146,52,20,632/- (Rupees One hundred and forty six crore fifty two lakh twenty thousand six hundred and thirty two only) for the procurement of the equipment to the above said hospital along with the department wise list of the equipment, justification for the essentiality of the equipment.

3. The State Empowered Committee headed by Chief Secretary has approved the above proposal and hence the Project Director, Tamil Nadu Health System Reform Program has requested the Government to issue the orders in this regard.

4. The Government after careful consideration on the above have decided to accept the same and accordingly issue the following orders:-

- (i) Sanction is accorded for a sum of Rs.146,52,20,632/- (Rupees One hundred and forty six crore fifty two lakh twenty thousand six hundred and thirty two only) towards the Procurement of Equipment (list annexed to this

order) for the Newly Built 1000 bedded Kalaignar Memorial Multi Super Speciality Hospital in the premises of King Institute of Preventive Medicine and Research, Guindy, Chennai, through Tamil Nadu Medical Services Corporation Limited.

- (ii) The Director of Medical Education is permitted to draw and deposit the sanctioned amount above into the Personal Deposit Account of Tamil Nadu Medical Services Corporation Limited towards the procurement of equipment.
- (iii) A separate SB account to be maintained exclusively for Tamil Nadu Health System Reform Program funds in Directorates and facilities involved which should be operated by joint signatory.

5. For the expenditure sanctioned in para 4 (i) above shall be debited to the following head of account:-

6. Necessary additional funds of Rs.146,52,20,632/- for Procurement of Equipment will be provided in Revised Estimate / Final Modified Appropriation 2023–2024. Pending provision of such funds, the Director of Medical Education is authorized to draw and disburse the amount sanctioned in para 4 above. However, this expenditure shall be brought to the notice of the Legislature by “Specific Inclusion” to the Supplementary Estimates 2023-2024. The Director of Medical Education is also requested to include this expenditure while sending the budget proposals for Revised Estimate / Final Modified Appropriation 2023-2024 and also send necessary draft explanatory notes for specific inclusion in the Supplementary Estimates 2023-2024 to Government in Finance (BG-I/Health-II) Department at an appropriate time without fail.
