ORDER:

In the circumstances reported by the Project Director, Tamil Nadu Health System Reform Program in the letter read above, the following amendment shall be issued to G.O.(Ms)No.385, Health and Family Welfare (EAPI-1) Department, Dated: 01.11.2022.

Amendment

- (i) for the existing para 4(i) shall be substituted as,
 - "Administrative sanction is accorded for a sum of Rs.60,00,00,000/towards construction of a Neuro Science Block in Rajiv Gandhi Government General Hospital, Chennai through Public Works Department. Further financial sanction is accorded for a sum of Rs.2,00,00,000/- for the financial year 2022-2023. The balance amount will be released in the subsequent financial years".
- (ii) for the existing para 7 shall be substituted as,
 - "Necessary additional funds of Rs.2,00,00,000/- will be provided in Final Modified Appropriation 2022-2023. However, this expenditure shall be brought to the notice of the Legislature by "Specific Inclusion" to the Supplementary Estimates 2022-2023. The Director of Medical Education is also requested to include this expenditure while sending the budget proposals for Final Modified Appropriation 2022-2023 and also send draft explanatory notes for specific inclusion in the Supplementary Estimates 2022-2023 to Government in Finance (BG-I/Health-II) Department at an appropriate time without fail".

- 2. With respect to purchases of Medical Gas Pipeline System and Medical Equipment to Neuro Science Block will be provided in the Financial Year 2023-2024.
