ORDER:

In the circumstances reported by the Project Director, Tamil Nadu Health System Reform Program in the letter read above, the following amendment shall be issued to G.O.(Ms)No.386, Health and Family Welfare (EAPI-1) Department, Dated: 01.11.2022.

Amendment

- (i) for the existing para 5(i) shall be substituted as,

“Administrative sanction is accorded for a sum of Rs.10,50,00,000/- (Rupees Ten Crore and fifty lakh only) for the construction of additional CEmONC Block at Government Medical College Hospital, Sivagangai District through Public Works Department. Further financial sanction is accorded for a sum of Rs.50,00,000/- (Rupees Fifty lakh only) for the financial year 2022-2023. The balance amount will be released in the subsequent financial years based on the requirements”.

- (ii) for the existing para 8 shall be substituted as,

“Necessary additional funds of Rs.1,74,74,000 (Rs.50,00,000/- for Civil + Rs.1,24,74,000/- for Equipment) will be provided in Final Modified Appropriation 2022-2023. Pending Provision of such funds in Final Modified Appropriation 2022-2023, the Director of Medical Education is authorized to draw and disburse the amount sanctioned above. However, this expenditure shall be brought to the notice of the Legislature by “Specific Inclusion” in the Supplementary Estimates 2022-2023. The Director of Medical Education is requested to include the

amount sanctioned above while sending the budget proposals for Final Modified Appropriation 2022-2023 and also send necessary draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates 2022-2023 to Government in Finance (HealthII/BG-1) Department without fail”.

(iii) for the existing para 10 shall be substituted as,

“This order issues with the concurrence of the Finance Department vide its U.O.No.8456/Finance (Health-II)/2022, Dated:20.03.2022 and ASL No.2682 (Two thousand six hundred and eighty two) (IFHRMS ASL No.2023032682).
