ORDER:

The Project Director, Tamil Nadu Health System Reform Program in the letter read above has stated that the Tamil Nadu Health Systems Project supported by the World Bank aims at improving the quality of care in primary, secondary, and tertiary care facilities. The disbursement-linked indicators - DLI#2, focuses on the accreditation of public facilities. DLI #2 is a scalable indicator with an allocation of US\$38.2 million (INR 266.19 Crores). As per the DLI #2, by the end of the Project period, 300 Primary Health Care facilities & 75 Secondary health care facilities should be NQAS certified. The amount disbursed in the first year (2019-20) of the project is as follows:

3. The Project Director, Tamil Nadu Health System Reform Program has furnished the list of PHCs/CHCs and Secondary Care Hospitals (as annexed to this Government Order) and requested NQAS certificate for the year 2021-2022 and funds may be provided under Tamil Nadu Health System Reform Program to Director of Public and Preventive Medicine at Rs.10 lakh per CHC for 22 CHCs and Rs. 7 lakh per PHC for 48 PHCs and Director of Medical and Rural Health Services at Rs.50,000/- per bed in 20 Sub District Hospitals.

4. The State Empowered Committee headed by Chief Secretary has approved the above proposal in the 3rd meeting of the State Empowered Committee.

5. The Project Director, Tamil Nadu Health System Reform Program has requested the Government to issue necessary orders in this regard.

6. The Government after careful examination of the proposal of the Project Director, Tamil Nadu Health System Reform Program have decided to accept the same and issue the following orders:-

- i. Sanction is accorded for a sum of Rs. 5.56 crore (Rupees Five Crore and Fifty Six Lakh only) to the Director of Public Health and Preventive Medicine towards NQAS certification for 48 PHCs at the rate of Rs.7.00 lakh per PHC/UPHC and for 22 CHCs at the rate of Rs.10.00 lakh (Rupees Ten lakh only) per CHC/UGPHC as in annexure-I to this Government Order.
- ii. Sanction is accorded for a sum of Rs.10.90 crore (Rupees Ten crore and ninety lakh only) to the Director of Medical and Rural Health Services towards NQAS certificate for 2180 beds in 20 Sub District Hospitals at the rate of Rs.50,000/- (Rupees fifty thousand only) per bed as in annexure-II to this Government Order.
- iii. The Director of Public Health and Preventive Medicine is authorized to draw and disburse the amount sanctioned at para 6 (i) above.
- iv. The Director of Medical and Rural Health Services is authorized to draw and disburse the amount sanctioned at para 6 (ii) above.
- v. A separate account to be maintained exclusively for Tamil Nadu Health System Reform Program funds in both Directorates and facilities involved which should be operated by Joint Signatory.

7. The expenditure sanction in para 6(i) above shall be debited to the following head of account:-

2210 – Medical and Public Health – 01 Urban Health Services – Allopathy – 200 Other Health Schemes – Externally Aided Project – PB – Tamil Nadu Health System Reforms Project – Administered by Director of Public Health - 309 Grants Aid – 03 Grants for Specific Schemes. (IFHRMS DPC 2210 01 200 PB 30903)

8. The expenditure sanction in para 6(ii) above shall be debited to the following head of account:-

2210 – Medical and Public Health – 01 Urban Health Services – Allopathy – 110 Hospitals and Dispensaries – Externally Aided Project – PD – Tamil Nadu Health System Reforms Project – Administered by the Director of Medical and Rural Health Services - 309 Grants in Aid – 03 Grants for Specific Schemes.
