ORDER:

During the Budget Speech for the year 2023-2024, the Hon'ble Minister for Finance and Human Resources Management has made the following announcement under the department of Health and Family Welfare on the floor of the Tamil Nadu Legislative Assembly on 20.03.2023:-

"திருச்சிராப்பள்ளி மற்றும் அதைச் சுற்றியுள்ள மாவட்டங்களின் உயர்மருத்துவ சிகிச்சைத் தேவைகளை நிறைவு செய்து வரும் மகாத்மா காந்தி நினைவு அரசினர் மருத்துவமனையில், 110 கோடி ரூபாய் செலவில் புதிய கட்டடங்கள் கட்டப்படும்".

- 2. Based on the above, the Project Director, Tamil Nadu Health System Reform Program in the letter read above, has sent a proposal towards construction of Broad Speciality Block (G+6 Floors) and additional floor over the existing ground floor of Ophthalmology Block at Mahatma Gandhi Memorial Government Hospital, Tiruchirappalli attached to K.A.P.Viswanatham Government Medical College at a cost of Rs.110.00 Crore. He has furnished the detailed justification, Statistics reports of General performance, Chief Minister's Comprehensive Health Insurance Scheme performance and detailed construction plan of the institution. The total area of the building is 19747.00 sq.m.
 - 3. The State Empowered Committee has approved the above proposal.
- 4. The Project Director, Tamil Nadu Health System Reform Program has requested the Government to issue the necessary orders in this regard. Further the Project Director, Tamil Nadu Health System Reform Program informed that the funds required for the financial year 2023-2024 for Rs.2.50 crore only out of Rs.110.00 crore. The rest of remaining funds for Rs.107.50 crore may be provided in the financial year 2024-2025.

- 5. After careful consideration of the proposal of the Project Director, Tamil Nadu Health System Reform Program, the Government have decided to accept the same and accordingly issue the following orders:-
 - (i) Administrative sanction is accorded for a sum of Rs.110,00,00,000/-(Rupees one hundred and ten crore only) towards construction of Broad Speciality Block (G+6 Floors) and additional floor over the existing ground floor of Ophthalmology Block at Mahatma Gandhi Memorial Government Hospital, Tiruchirappalli attached to K.A.P.Viswanatham Government Medical College through Public Works Department.
 - (ii) The Director of Medical Education and Research is permitted to draw and disburse the above sanctioned amount.
 - (iii) A separate account to be maintained exclusively for Tamil Nadu Health System Reform Program funds in Directorate, Districts and Facilities (till beneficiary level if needed) involved, which should be operated by Joint Signatory.
- 6. The expenditure sanctioned in para 5 (i) above shall be debited to the following head of account:-
 - "4210 Capital Outlay on Medical and Public Health 01 Urban Health Services 200 Other Health Schemes Externally Aided Projects PC Tamil Nadu Health Systems Reforms Project 416 Major works 01 Major works.

(IFHRMS DPC: 4210 - 01-200 - PC-41601)."

- 7. Necessary funds of Rs.2,50,00,000/- will be provided in Revised Estimate/ Final Modified Appropriation 2023 2024. Pending provision of such funds, the Director of Medical Education and Research is authorized to draw and disburse the above sanctioned amount. However, this expenditure shall be brought to the notice of the Legislature by Specific Inclusion in the Supplementary Estimates 2023-2024. The Director of Medical Education and Research is also requested to include this expenditure while sending the budget proposals for Revised Estimate / Final Modified Appropriation 2023 2024 and also send draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates 2023-2024 to Government in Finance (BG-I/Health-II) Department at an appropriate time without fail.
- 8. This order issues with the concurrence of the Finance Department vide the e-file No:4925448/2023, dated:06.01.2024 and ASL No.1671 (One thousand six hundred and seventy one). (IFHRMS ASL No.2024011671).
