ORDER:

The Hon'ble Minister for Health and Family Welfare has made the following Announcement in the floor of the Tamil Nadu Legislative Assembly during the Demand No. 19.

(Announcement No. 77):

2. Based on the above announcement, the Project Director, Tamil Nadu Health System Reform Program has sent proposal approved by the State Empowered Committee headed by Chief Secretary for Procurement of Hemoglobinometer to Anaemia Prevalent District (Piloting) and stated as follows:-

Based on the NFHS 4 result, the following districts have been identified as priority districts:

Full Antenatal Care as per World Bank:

- 1. Atleast 4 ANC visit
- 2. Atleast 1 TT Injection
- 3. IFA Tablet for 100 or more days

As prevalence of anaemia in pregnant women is 44.4% in NFHS 4 and 54.7% in NFHS 3 and may indirectly constitute maternal mortality, hence, early diagnosis of anaemia is necessary at HSCs, for which it is proposed that Hemoglobinometer may be provided to all the HSCs of the anaemia prevalent district as a piloting activity and procured through Tamil Nadu Medical Services Corporation. Testing of Haemoglobin using Digital Hemoglobinometer and Point of care treatment of Anaemia is a new intervention under "Anaemia Mukt Bharat" campaign. Digital hemoglobinometer will be used for testing of haemoglobin level. The digital Haemoglobinometer are point of care testing devices, used for estimation of haemoglobin near the beneficiary. The use of digital Hemoglobinometer for estimation of haemoglobin is approved by WHO and Indian Council of Medical research (ICMR). The Virudhunagar District has been selected based on the following data:
