### ORDER:

In the Government Order read above, three time-scale pay supernumerary post of Professor in Kilpauk Medical College, Chennai were created by redeployment of already sanctioned posts in Tamil Nadu Health System Reform Program / Tamil Nadu Urban Health Care Project as follows:-

2. The Project Director, Tamil Nadu Health System Reform Program in the letter read above has requested to sanction of Rs.74,81,340/- towards the recurring cost for



salary of above said three supernumerary posts for the year 2023-2024 which was approved by the State Empowered Committee and furnished the estimation as follows:-

3. The Government after careful consideration of the Project Director, Tamil Nadu Health System Reform Program and has decided to accept the proposal. Accordingly the following orders are issued:-

- Sanction is accorded for a sum of Rs.74,81,340/- (Rupees Seventy four lakh eighty one thousand three hundred and forty only) towards the salary of the three time-scale pay supernumerary posts sanctioned for Government Kilpauk Medical College, Chennai
- During the Project period, the sanctioned amount is funded under Tamil Nadu Health System Reform Project / Tamil Nadu Urban Health Care Project, that fund is reallocated to the Director of Medical Education and Research.
- The Director of Medical Education and Research is authorized to draw and disburse the amount sanctioned in para 3(i) above.
- As these supernumerary posts are to be attached to Department of Medicine, Surgery and Orthopaedics of Kilpauk Medical College Hospital, Director of Medical Education side Professors may be posted and work in Tamil Nadu Health System Reform Project to monitor the Director of Medical Education approved activities like Trauma care, NCD, Mental Health, NABH accreditation without losing their Teaching Experience.
- A separate account to be maintained exclusively for Tamil Nadu Health System Reform Project funds in both Directorates and Facilities involved which should be operated by Joint Signatory.
- There is no additional expenditure to Government as it involves only redeployment of already sanctioned posts to Tamil Nadu Health System Reform Project / Tamil Nadu Urban Health Care Project.
- The above 3 posts created temporarily by redeployment only till Tamil Nadu Health System Reform Project / Tamil Nadu Urban Health Care Project is alive or the requirement ceases to exist, whichever is earlier. Once this funding under Tamil Nadu Health System Reform Project / Tamil Nadu Urban Health Care Project comes to a close, the 3 posts will automatically expire. There will be no continuation of these posts after Tamil Nadu Health System Reform Project / Tamil Nadu Urban Health Care Project ends. Whoever posted in this supernumerary posts of Kilpauk Medical College Hospital, will be automatically diverted to Office of Tamil Nadu Health System Reform Project to co-ordinate with Director of Medical Education side activities.
