#### ORDER:

The Hon'ble Minister for Health and Family Welfare has made the following Announcement in the floor of the Tamil Nadu Legislative Assembly during the Demand No.19.

### Announcement No:9

"தமிழ்நாடு சுகாதார சீரமைப்புத் திட்டத்தின் கீழ், திண்டுக்கல் மாவட்டம் பழனி அரசு மருத்துவமனைக்கு ரூ.1.00 கோடி மதிப்பீட்டில் டிஜிட்டல் எக்ஸ்ரே கருவி வழங்கப்படும்".

- 2. The Project Director, Tamil Nadu Health System Reform Program in the letter read above has sent a proposal towards the provision of digital X-ray at a rate of Rs.1.00 crore to the Government District Head Quarters Hospital, Palani, Dindigul District, which is a Level III TAEI Centre and also empanelled under Nammai Kaakum 48 Innuyir Kaapoom Thittam along with the justification for the activity and statistical reports of the institution.
  - 3. The State Empowered Committee has approved the above proposal.
- 4. The Project Director, Tamil Nadu Health System Reform Program therefore requested the Government to issue the orders in this regard.
- 5. After careful consideration of the proposal of the Project Director, <sup>¬</sup>ramil Nadu Health System Reform Program, the Government have decided to accept the same and accordingly issue the following orders:-
  - (i) Sanction is accorded for a sum of Rs.1,00,00,000/- (Rupees One crore only) towards the procurement of digital X-ray in Government District Headquarters Palani Hospital, Dindigul District.
  - (ii) The Director of Medical and Rural Health Services to draw the amount sanctioned above and deposit the same in to the Personal Deposit account of the Managing Director, Tamil Nadu Medical Services Corporation Limited so as to procure the equipment.

- (iii) A separate account to be maintained exclusively for Tamil Nadu Health System Reform Program funds in Directorates involved, which should be operated by Joint Signatory.
- 6. The expenditure sanctioned in para 5 (i) above shall be debited to the following head of account:-
  - 2210 Medical and Public Health 01 Urban Health Services Allopathy -110 Hospitals and Dispensaries – Externally Aided Projects-PD- Tamil Nadu Health System Reform Project – Administrated by the Director of Medical and Rural Health Services - 319 Machinery and Equipments - 01 Purchase (DPC 2210 - 01-110 - PD-31901)
- 7. Necessary funds of Rs.1,00,00,000/- will be provided in Revised Estimate/ Final Modified Appropriation 2023-2024. Pending provision of such funds, the Director of Medical and Rural Health Services is authorized to draw and disburse the above sanctioned amount. However, this expenditure shall be brought to the notice of the Legislature by Specific Inclusion in the Supplementary Estimates 2023-2024. The Director of Medical and Rural Health Services is also requested to include this expenditure while sending the budget proposals for Revised Estimate / Final Modified Appropriation 2023-2024 and also send draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates 2023-2024 to Government in Finance (BG-I/Health-II) Department at an appropriate time without fail.
- 8. This order issues with the concurrence of the Finance Department vide its U.O.No.25841/Health-II/2023, Dated:11.07.2023 and ASL No.486 (Four Hundred and Eighty Six) (IFHRMS ASL No.2023070486).
