The Hon'ble Minister for Health and Family Welfare has made the following announcement on the floor of the Tamil Nadu Legislative Assembly:-

As a part of the above announcement, the Project Director, Tamil Nadu Health System Reform Program has sent a proposal for sanction an amount of Rs.67,00,000/towards providing electrical lifts arrangements for Thoracic Medicine Ward at Government Rajaji Hospital, Madurai District under Tamil Nadu Health System Reform Program fund.

3. The State Empowered Committee has approved the above proposal.

4. The Government, after careful examination, have decided to accept the request of the Project Director, Tamil Nadu Health System Reform Program and order accordingly on the following:-

i. Sanction is accorded for a sum of Rs.67,00,000/- (Rupees Sixty seven lakh Only) towards providing electrical lifts arrangements for Thoracic Medicine Ward at Government Rajaji Hospital, Madurai District through Public Works Department.

- ii. The Director of Medical Education and Research is permitted to draw and disburse the amount sanctioned in para 4(i) above.
- iii. The Public Works Department is requested to submit the Monthly Expenditure Statement to the Director of Medical Education and Research.

5. The expenditure sanctioned in para 4(i) above shall be debited to the following head of account:-
