ORDER:

The announcement made by the Hon'ble Minister for Health and Family Welfare on the floor of the Tamil Nadu Legislative Assembly as follows:-

2. The Thanjavur Medical College Hospital has been established in 1964 and is the only tertiary care Hospital, which caters not only the people of Thanjavur District but also many Neighboring districts. It is functioning with 1466 beds. No separate building is available for Stores and Temporary places created and utilised for stores which is not spacious to hold all the indent. In addition, it is the place where high end equipment are purchased and maintained for the treatment given in the speciality departments. So, it is necessary to have adequate space for the functioning of the main store. Hence, it is proposed to construction of OP Block for Super Speciality Care with Medical and Surgical Stores (G+2 Floors) at Government Thanjavur Medical College Hospital, Thanjavur at a cost of Rs.9.23 crores under Tamil Nadu Health System Reform Program World Bank Funds.

3. The Project Director, Tamil Nadu Health System Reform Program has justified the above activity and furnished the budget estimate for the proposed work as follows:-

4. The State Empowered Committee has approved the above proposal.

The Government, after careful examination, have decided to accord an administrative sanction at a total cost of Rs.9,23,00,000/-(Rupees Nine core twenty three lakh only) towards construction of OP Block for Super Speciality Care with Medical and Surgical stores (G+2 Floors) to the Government Thanjavur Medical College Hospital, Thanjavur District through Public Works Department under Tamil Nadu Health System Reform Program World Bank fund and issue order accordingly.
