ORDER:

The Project Director, Tamil Nadu Health Systems Project has reported that consequent on the ending of World Bank funding support with effect from 15.09.2015, the project period of Tamil Nadu Health Systems Project came to an end on that date.

2. The Project Director has reported that over the years, the project had initiated many programmes, some of which are innovative and some are restructuring of already implemented activities by bringing in protocols, policies and systems, that many of these activities need to be continued beyond the project period by integrating them into the regular Public Health system and that these programmes have to be handed over to the Directorates for their continued implementation. The Project Director has further stated that a meeting was convened on 23.02.2015 with the Head of the Directorates to discuss and decide about the programmes to be handed over to them and based on the decisions arrived at in the meeting, he has sent proposal to the Government for handing over of the activities of the project to the Head of Departments.

- 3. The Project Director, Tamil Nadu Health Systems Project had also placed a proposal before the State Empowered Committee in the meeting held on 13.07.2015 for handing over of the activities of the project to the Head of Departments under the control of the Health and Family Welfare Department with effect from 16.09.2015. The State Empowered Committee had approved the proposal. The Project Director, Tamil Nadu Health Systems Project has requested the Government to issue orders in the matter.
- 4. The Government have examined the proposal of the Project Director, Tamil Nadu Health Systems Project and after careful consideration, the Government direct that the programmes implemented by the Tamil Nadu Health Systems Project shall be handed over to the other Head of Departments under the control of the Health and Family Welfare Department with effect from 16.09.2015, as indicated below:

I. Comprehensive Emergency Obstetric and New Born Care Services (CEmONC)

- a. The CEMONC services in 106 hospitals under the control of the Director of Medical and Rural Health Services shall be handed over to the Director of Medical and Rural Health Services. The details of hospitals are indicated in Annexure I to this order.
- b. The CEmONC services in 20 tertiary care hospitals under the control of the Director of Medical Education shall be handed over to the Director of Medical Education. The details of hospitals are indicated in Annexure II to this order.
- c. The funds for the Contract Staff, training programmes, conducting review meetings, certification and recertification etc., shall be met out from the Reproductive Child Health (RCH) programme of National Rural Health Mission. If the funds are not available under National Rural Health Mission, the Government may be addressed for provision of funds.
- d. The system of payment of contingent expenditure by the National Rural Health Mission based on the number of deliveries in the CEmONC hospitals shall be continued.

II. Tribal Health Development Activities:

- a. Under the Tribal Health Development activities, Mobile outreach health services in Tribal areas, Bed Grant Scheme and Sickle Cell Anaemia Programme shall be handed over to the Director of Public Health and Preventive Medicine.
- b. The scheme of appointing Tribal patient counsellors in Hospitals and Primary Health Centres in Tribal areas shall be handed over to the Director of Medical and Rural Health Services.
- c. Funds for implementing the programmes will be provided by the National Rural Health Mission.

III. Non Communicable Diseases Intervention Programme:

- a. The implementation of Non Communicable Diseases (NCD) intervention programme in tertiary care hospitals shall be handed over to the Director of Medical Education.
- b. The implementation of NCD intervention programme in Secondary care hospitals shall be handed over to the Director of Medical and Rural Health Services.
- c. The implementation of NCD intervention programme in Primary Health Centres and Municipal Dispensaries shall be handed over to the Director of Public Health and Preventive Medicine
- d. The programme will be funded by the National Rural Health Mission through National Programme for Prevention and Control of Cancer, Diabetes, Cardiovascular Disease and Stroke Programme.

IV. Health Management Information System and State Health Data Resource Centre

- a) The implementation of Health Management Information System (HMIS) and its monitoring in tertiary care hospitals shall be handed over to the Director of Medical Education.
- b) The implementation of HMIS and its monitoring in Secondary care hospitals shall be handed over to the Director of Medical & Rural Health Services.
- c) The implementation of HMIS and its monitoring in Primary Health Centres shall be handed over to the Director of Public Health and Preventive Medicine.
- d) The programme will be funded by the National Rural Health Mission. If funds are not provided by the National Rural Health Mission, the Government may be approached for provision of funds.

V. Quality of Care Improvement Activities:

- a. Quality of Care Improvement activities and accreditation of Government Hospitals shall be handed over to the Director of Medical and Rural Health Services.
- b. The programme will be funded by the National Rural Health Mission.

Vi. Infection Control and Waste Management:

- a. The implementation of Infection Control and Waste Management in tertiary care hospitals shall be handed over to the Director of Medical Education.
- b. The implementation of Infection Control and Waste Management in Secondary care hospitals shall be handed over to the Director of Medical and Rural Health Services.
- c. The implementation of Infection Control and Waste Management in Primary Health Centres shall be handed over to the Director of Public Health and Preventive Medicine

- d. The programme will be funded by the National Rural Health Mission in respect of Secondary Care Hospitals and Primary Health Centres.
- e. In respect of the tertiary care hospitals, funds are already provided by the Government.

VII. Human Resource Development - Skill based and Managerial Training Programmes:

- a. Implementation of skill based and managerial Training Programmes shall be handed over to the Director of Medical and Rural Health Services.
- b. The programme will be funded by the National Rural Health Mission. If funds are not provided by the National Rural Health Mission, the Government may be approached for provision of funds.

VIII. Hospital Equipment Maintenance System

- a. The hospital equipment maintenance system shall be continued by the Bio Medical Engineers appointed under the control of Director of Medical Education and the Director of Medical and Rural Health Services. At present the Bio Medical Engineers are working under the administrative control of the Tamil Nadu Medical Services Corporation. This system will continue.
- 5. Sanction is accorded for continuance of the 28 posts indicated in Annexure III to this order to work in the Core Tamil Nadu Health Systems Project for the period from 16.09.2015 to 31.03.2016.
- 6. Sanction is accorded for incurring an expenditure of Rs.26.50 lakh (Rupees twenty six lakh and fifty thousand only) to meet the non-salary items of expenditure indicated in Annexure IV to this order from the Tamil Nadu Health Systems Project fund.
- 7. The Government also direct that 3 vehicles shall be retained by the Project and the remaining vehicles shall be surrendered to the State Health Transport Department.
- 8. This order issues with the concurrence of the State Empowered Committee constituted in G.O. (Ms).No.28, Health and Family Welfare Department, dated 28.02.2005 and Finance Department vide its .U.O.No.79/ADS(Dr.PU)/Health-II/2016, dated: 04.03.2016.
