### **ORDER:**

The Hon'ble Minister for Health and Family Welfare has made the following announcement (Announcement No.29) on the floor of the Tamil Nadu Legislative Assembly.

2. The Project Director, Tamil Nadu Health System Reform Program in the letter read above has stated that the Kanyakumari Government Medical College Hospital is located in the southernmost part of Tamil Nadu. The hospital was established in 2004 by converting the Tuberculosis Hospital building, and since then, the campus has undergone several developments, it is now a 1206 bedded hospital with an average Outpatient of 2205 per day and 861 admissions in Inpatient per day. The hospital campus has a total of 32 buildings, with 12 modern constructions and 20 older buildings. The Department of General Surgery has 15 Doctors and 11 Postgraduate Students enrolled per year since 2019. On an average, the Hospital conducts 821 major surgeries per month under Chief Minister's Comprehensive Health Insurance Scheme and has earned Rs.1,42,73,815 in the year 2022. He has justified the reasons for the need for the infrastructure strengthening with the provision of equipment in Kanyakumari Government Medical College Hospital and furnished the additional statistical reports as year wise General Performance, Chief Minister's Comprehensive Health Insurance Scheme performance of the institution.

3. The Project Director, Tamil Nadu Health System Reform Program has further stated that the provision of advanced laparoscopy equipment for the Kanyakumari Government Medical College and Hospital is of paramount importance for several



reasons. The hospital needs to provide advanced laparoscopy training to its postgraduate students, as per National Medical Council guidelines. With only one functioning single-chip camera set, the hospital is unable to cater to the needs of patients requiring advanced laparoscopic procedures. Despite the Doctors being well-trained in laparoscopy, they are often forced to perform open surgeries due to the unavailability of the necessary equipment. By providing a high-definition advanced laparoscopic set, the hospital will be able to perform more cases under the Chief Minister's Comprehensive Health Insurance Scheme, improve the quality of care provided to patients, avoid out-of-pocket expenditure, reduce the duration of stay in the hospital, and increase its revenue. After the COVID-19 pandemic, the hospital experienced an increase in cases of varicose vein disorders and Post-Phlebotic limbs. In the past, patients with these conditions would have undergone an open Trendelenburg procedure, which required a longer hospital stay and was associated with more pain and discomfort for the patient. However, in recent years, Radio Frequency ablation (RFA) therapy has revolutionized the treatment of varicose veins and related diseases. With Radio Frequency ablation, a minimally invasive technique, patients experience less pain, shorter hospital stays, and a quicker recovery time. Endovascular therapy, which is another minimally invasive approach to treating vein disorders, can also be used if a Radio Frequency Ablation machine is available. He has furnished the budget estimation as detailed below:-

4. The State Empowered Committee has been approved the above proposal.

5. The Project Director, Tamil Nadu Health System Reform Program <sup>has</sup> therefore requested the Government to issue the orders in this regard and to sanction out of Rs.2,00,00,000/- the amount of Rs.1,00,00,000/- for this financial year 2023-2024 and the balance amount of Rs.1,00,00,000/- for next financial year 2024-2025.

6. The Government, after careful examination, have decided to accept the proposal of the Project Director, Tamil Nadu Health System Reform Program and accordingly issue the following orders:-

- (i) An administrative sanction is accorded for a sum of Rs.1,45,00,000/- (Rupees one crore and forty five lakh only) towards the infrastructure strengthening (Laying of Roads within the campus) for the Kanyakumari Government Medical College Hospital through the Public Works Department.
- (ii) An administrative sanction is accorded for a sum of Rs.55,00,000/- (Rupees Fifty five lakhs only) towards the procurement of advanced laparoscopy set and a Radio Frequency Ablation Machine to the Kanyakumari Government Medical College Hospital through the Tamil Nadu Medical Services Corporation Limited. The list of required equipment is annexed to this order.



- (iii) The Director of Medical Education and Research is authorized to draw and disburse the sanctioned amount at para 6(i) and (ii) above.
- (iv) The Director of Medical Education & Research is directed to maintain a separate Saving Bank account exclusively for Tamil Nadu Health System Reform Program funds in Directorate/ District Health Society and facilities involved which should be operated by Joint Signatory.

7. The expenditure sanctioned in para 6 (i) above shall be debited to the following head of account:-

4210 – Capital Outlay on Medical and Public Health - 01 Urban Health Services – 200 Other Health Schemes – Externally Aided Project - PC – Tamil Nadu Health Systems Reforms Project – 416 Major Works – 01 Major Works.

8. The expenditure sanctioned in para 6 (ii) above shall be debited to the following head of account:-

2210 – Medical and Public Health – 01 Urban Health Services - Allopathy – 110 Hospitals and Dispensaries – Externally Aided Projects – PE – Tamil Nadu Health System Reform Project – Administred by the Director of Medical Education – 319 Machinery and Equipment – 01 Purchase (IFHRMS 2210-01-110-PE-31901) - **Rs.55,00,000/-**

9. Necessary funds of Rs.1,00,00,000/- will be provided in Final Modified Appropriation 2023-2024. Pending provision of such funds, the Director of Medical Education and Research is authorized to draw and disburse the above sanctioned amount. However, this expenditure shall be brought to the notice of the Legislature by Specific Inclusion in the Supplementary Estimates 2023-2024. The Director of Medical Education and Research is also requested to include this expenditure while sending the budget proposals for Final Modified Appropriation 2023-2024 and also send draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates 2023-2024 to Government in Finance (BG-I/Health-II) Department at an appropriate time without fail.
